#### Introduction from Nathan Butler, Superintendent

Nathan Butler currently serves as the Superintendent for the Hospital District, which functions in a similar fashion to the Chief Executive Officer of a company. Nathan's job involves overseeing the operation of San Juan Island EMS and Village at the Harbor by managing budgets, high level

employees, and ensuring that relations between community partners of the Hospital District are in good health.

In addition to Nathan's roles as the Superintendent, he also serves as the department head for San Juan Island EMS. He highlighted some of his main responsibilities, stating, "For EMS, I go on aid calls when needed, hire personnel, handle union negotiations, determine District investments, and otherwise manage the system. However, I do spend about a quarter of my time on non-EMS specific things, like working to expand long-term care, building budgets, or working with the Board of Commissioners and Village leadership." "My work is varied and interesting and requires that I trust my management team. It is a small team for a large entity with multiple service lines, and one of the largest employers on the island. Village at the Harbor has Evan Perrollaz as Administrator, and Tina Smith as Assistant Administrator. Assistant Chief Thaddeus (T. J.) Bishop helps me run San Juan Island EMS. All are dedicated and work many extra hours in service to the public."

The Hospital District is fortunate to be led by a board of five commissioners, who we've chosen to spotlight in this issue of the newsletter. As a property-tax based system, it is vital that the community knows the Hospital District Commissioners to ensure accountability. Each commissioner brings their different backgrounds and perspective, but all represent the public in setting the goals and priorities of the District. They put in many uncompensated hours serving the public. The District has been very successful these last few years, and a big part of that is our Board of Commissioners!

#### EVERETT CLARY

Everett Clary has been a resident of San Juan Island for over 20 years. He loves waking up to the beauty of the island and being surrounded by the kind and accepting people who live here.

Everett ran for the position of commissioner because of his desire to give back to the community: "The people of San



Juan Island have been very good to me and my wife, so I felt it was time to give back to them and participate in what has been such a wonderful place to live".

As a commissioner, Everett is most passionate about long-term care: "People often find themselves in a situation where they need help with their healthcare. Help with healthcare is not just a matter of money, frequently it has more to do with availability and I am passionate about making healthcare (including long term care) available to those who need it."


vaccines and administering them through San Juan County.

It is hard to believe that fall has arrived, and we are heading into the latter part of 2022. This year has been a whirlwind as we have fully integrated Village at the Harbor into the Hospital District. We are excited about the initiatives we are currently rolling out, and proud of the exceptional value we are creating for our residents and team members.

For starters, we have fully implemented our concierge program, with supported visits to medical appointments and shopping. Our newest van includes a wheelchair ramp ensuring that our limited mobility residents receive first rate service to get to and from medical appointments on scheduled days, as well as enjoying many of the scenic outings they were previously unable to participate in.

Secondly, we are wrapping up the approvals to launch our very own Home Care Aide training program. I am personally truly grateful that we will be able to focus our energies to provide hands-on, real-time training to our team members and ensure their unlimited growth as care providers. We have such a dedicated and passionate group of professionals that work here. Giving them additional resources and tools has been a dream for many years. We continue to work on team development with an eye towards the near future when we work to launch our Home Care Agency in 2023.

Lastly, I have been struck by how many conversations I have had recently with people that greatly support the work

we are doing. It is with absolute pleasure that I get the opportunity to work among so many great people from my team and the large contingent of outside professionals that we interact with. #### SAN JUAN ISLAND EMS

#### Nathan Butler, Administrator

San Juan Island EMS has accomplished many changes over the course of 2022:

- Completing an EMT class, adding about a dozen new volunteers to our ranks. Their energy and excitement add immeasurably to our agency
- Renewed our levy in February with fantastic public support
- Hired an Assistant Chief to add key management depth and expand training for responders
- Margaret Longley completed training with the Medic One / Harborview program and returned to our agency as a fulltime medic

In January 2023, San Juan Island EMS will be accommodating the consistent increase in call volume over the past few years by moving paramedics from oncall shifts to in-station shifts like staff EMTs. A paramedic requires a more advanced certification than an EMT, requiring at least a year of intensive training. Adding Paramedic Longley is essential to making in-station shifts work. This is because in-station shifts are more demanding than the current system, as they reduce shifts per paramedic by about 33%. EMS has been adapting to being part of a larger District that does more things than just emergency medical services. Less exciting projects are also underway, such as rewriting a set of shared policies and procedures, strategic planning, new budgets, negotiating a new Collective Bargaining Agreement for 2023 – 2025, and more. In October, we held "Accountability Month," ensuring that all of our staff received necessary training in HIPAA, public records, safety, and more.

We sincerely appreciate the public's support, as we work together to care for our precious community.

#### NOVEDADES DE SAN JUAN ISLAND EMS

El EMS de la isla de San Juan ha logrado muchos cambios en el transcurso de 2022:

- Completar una clase de EMT, agregando alrededor de una docena de nuevos voluntarios a nuestras filas. Su energía y entusiasmo se suman inmensamente a nuestra agencia.
- Renovamos nuestra tasa en febrero con un apoyo público fantástico
- Contrató a un subjefe para agregar profundidad de gestión clave y ampliar la capacitación para los socorristas
- Margaret Longley completó la capacitación con el programa Medic One / Harborview y regresó a nuestra agencia como médico de tiempo completo

En enero de 2023, el EMS de la isla de San Juan se adaptará al aumento constante en el volumen de llamadas durante los últimos años al trasladar a los paramédicos de turnos de guardia a turnos en la estación como técnicos de emergencias médicas. Un paramédico requiere una certificación más avanzada que un EMT, lo que requiere al menos un año de capacitación intensiva. Agregar al paramédico Longley es esencial para que los turnos en la estación funcionen. Esto se debe a que los turnos en la estación son más exigentes que el sistema actual, ya que reducen los turnos por paramédico en aproximadamente un 33 %.

EMS se ha estado adaptando para ser parte de un Distrito más grande que hace más cosas que solo servicios médicos de emergencia. También están en marcha proyectos menos emocionantes, como reescribir un conjunto de políticas y procedimientos compartidos, planificación estratégica, nuevos presupuestos, negociar un nuevo Acuerdo de negociación colectiva para 2023-2025 y más. En octubre, celebramos el "Mes de la responsabilidad", asegurándonos de que todo nuestro personal recibiera la capacitación necesaria en HIPAA, registros públicos, seguridad y más.

Agradecemos sinceramente el apoyo del público, mientras trabajamos juntos para cuidar de nuestra preciosa comunidad.




PeaceHealth Peace Island Medical Center (PIMC) is a critical access hospital and clinic located in Friday Harbor, WA, and the only hospital in San Juan County. It provides clinical and emergency care, as well as physical therapy, cancer services, lab services, and access to visiting specialists.

Approximately one-third of the revenues for PIMC are provided by a subsidy from San Juan County Public Hospital District No. 1. This money comes from taxpayers to ensure these services remain in our community and supports generous charity care programs for those who cannot afford services.

PeaceHealth provides biannual reports to the Hospital District Board of Commissioners. Included in this article are some of the key takeaways from the PeaceHealth's Bi-Annual Report spanning from January 1st through June 30th, 2022. ### Did you know Village at the Harbor offers Respite Stays?

For many residents of San Juan Island, a hospitalization or recent rehabilitation stay may leave you not quite ready to go home. Village at the Harbor offers one beautiful, fully furnished apartment for your recovery. Whether you've recently had surgery, are recovering from an illness, or looking for a temporary place for your grandparent, who is moderately handicapped or impaired, to stay while you're out of town, Village at the Harbor is the preferred destination for your short-term stay.

Respite care at Village at the Harbor is available for up to one month and is a suitable accommodation for individuals looking for assistance with daily living tasks on a short-term basis. Respite care residents have access to all of Village at the Harbor's amenities, including free homemade meals, laundry services, housekeeping, a nursing care team, care coordination with physical and occupational therapists, and regular activities and outings.

Agreements for respite care are daily and you are never locked into a contract. Rates are straightforward, with a flat rate of \$275 per day. Our short-term stays include a fully furnished apartment unit, an emergency call pendant for 24/7 access to our care team, personal care if needed, meals, activities, and health coordination. For individuals concerned about the cost of short-term stays, grants and funding may be available under certain circumstances.

Lainey Volk was nominated and chosen for the "2022 EMS World/Dynarex EMS Caring Award," which is given to EMS professionals who show outstanding dedication to their community. This award is nationally recognized at the EMS World convention which took place this year on October 10th, in Orlando, Florida.

Lainey Volk has served the San Juan Island community as a member of San Juan Island EMS for over 32 years. She is currently the Director of Outreach and Community Paramedicine. Many members of the community may recognize her from the CPR, First Aid, and Basic Life Support (BLS) courses she teaches to the public at reduced rates through San Juan Island EMS. Volk's dedication to healthcare education plays a large role in the reason why San Juan County has one of the highest saves rates from cardiac arrest in the nation.

In addition to the educational courses Volk offers the public, she also directs the Community

Paramedicine section of San Juan Island EMS, which works with vulnerable community members to provide care coordination, injury prevention, and follow-up visits. Community Paramedicine provides grab bars, safety poles, medication dispensers, walkers, and car seats to members of the public.

T. J. Bishop, Assistant Chief of Operations and Training, nominated Lainey Volk for the EMS Caring Award. Bishop noted that, "She has trained thousands of health care professionals and community members, [and] indirectly contributed to saving countless lives in the San Juan Islands due to her love of community service and servant leadership."

Congratulations, Lainey, on your well-deserved recognition. Volk, along with two other members of San Juan Island EMS, traveled to the EMS World Expo in October to attend the event. Volk received her award in person, with all travel expenses paid for by EMS World.
